# 1 Introduction

Welcome to the Kellas group Cookie Policy ("**Policy**"). References throughout this Policy to "Kellas", "we" and "our" shall refer to Kellas Midstream Limited and its group companies, including H2NorthEast Limited, collectively or individually as the context shall require.

This Policy aims to give you information on how Kellas manages cookies on our websites – <a href="https://www.kellasmidstream.com">www.kellasmidstream.com</a> and <a href="https://www.h2northeast.com">www.h2northeast.com</a> ("our websites").

# 2 Process

#### What are Cookies:

Cookies are small text files that are placed on your computer or device by the websites that you visit. They are widely used to make websites function properly, operate more efficiently, and provide information to the site owners. The use of cookies is now standard for most websites. If you are uncomfortable with the use of cookies, you can manage and control them through your browser settings. This includes removing cookies by deleting them from your 'browser history' (cache) when you leave the site.

#### Types of Cookies We Use:

- Session Cookies: These remain in your browser during your session only, i.e., until you leave the website.
- Persistent Cookies: These remain in your browser after the session (unless deleted by you).
- **Performance Cookies**: These collect information about your use of the website, such as pages visited and error messages. They do not collect personally identifiable information, and the data collected is aggregated and anonymised. Performance cookies help us improve how the website functions.
- Functionality Cookies: These allow the website to remember choices you make (such as language
  preferences or text size) or enable services like commenting on a blog. They personalise your
  experience and improve usability.

#### **Managing Cookies:**

You can manage and control cookie settings via your browser. Most browsers automatically accept cookies, but you can modify your browser settings to decline cookies or remove them after your session. For detailed guidance on how to control or delete cookies, visit your browser's help documentation.

Be aware that opting out of certain cookies may affect the functionality of the website and limit your ability to use some features.

When you first visit our websites, you will see a pop-up banner asking you to accept or reject the use of cookies. By clicking 'Accept Cookies,' you consent to the placement of cookies on your device. If you choose to decline cookies, only strictly necessary cookies will be used, but this may affect your website experience.

#### **Strictly Necessary Cookies:**

Necessary cookies enable core functionality such as page navigation and access to secure areas. The website cannot function properly without these cookies and can only be disabled by changing your browser preferences.

#### **Retention Period of Cookies:**

Cookies remain on your device for varying durations:

• Session Cookies are deleted once your browser is closed.

• **Persistent Cookies** remain on your device until you delete them or until they expire, as per the durations set out in the table above.
